



- 3. Your personal data will be processed for the following purposes:
 - a. conducting recruitment for participation in the project 'Across Cross-border European University' pursuant to art. 6 1 item e GDPR;
 - b. contact in connection with the recruitment process on the basis of the consent granted for the processing of the contact telephone number art. 6 1 item a GDPR;
