

EVENT REGULATIONS

Name of the event: Pumpkin Party

General provisions

1. The organizer of the event called Pumpkin Party, hereinafter referred to as the Event, is Department of International Projects Erasmus+ and NAWA and Mobility and International Agreements Unit, hereinafter referred to as the Organizer.
2. Event is organized and financed within „Akcja-Integracja 2.0” project coordinated within Welcome to Poland Programme financed by NAWA.
3. Event Participant - a person authorized to participate in the Event, who is a student or a foreign student, registered via online form published on Organizer's website.
4. Event area : Academic Sports Center, Games Hall.
5. Event security coordinator - a person appointed by the Organizer, representing it in ensuring the safety of Event participants : Marta Orpik, m.orpik@pb.edu.pl.
6. Security personnel, volunteers - persons acting under the authority of the Organizer, responsible for the proper conduct of the Event.
7. Event Regulations - defines the conditions of participation, organizational and order rules applicable at the event area.
8. The Regulations are addressed to all persons who will stay in the area where the Event is held during the Event. Each person staying at the Event Venue during the Event is obliged to comply with the provisions of these Regulations.
9. The purpose of the Regulations is to define the rules of behavior of people present at the Event and their use of the area where the Event is held.
10. The aim of the Event is to integrate international students of the Białystok University of Technology.

Organizational and order rules

1. The event is closed and intended mainly for international students of the Białystok University of Technology.
2. The organizer has the right to refuse entry to the event area and stay there:
 - a) A person who is visibly under the influence of alcohol, narcotic drugs, psychotropic substances or similar substances.
 - b) A person behaving aggressively, provocatively or otherwise posing a threat to public safety or order.
 - c) A person in possession of weapons or other dangerous objects, explosives, pyrotechnic articles, fireworks, firecrackers, fire-hazardous materials, alcoholic beverages, narcotic drugs or psychotropic substances, spray paints and other aerosols, devices emitting laser rays, flags, banners, sound-emitting devices, animals, racist, xenophobic and propaganda materials, as well as posters and leaflets without authorization from the Organizer.
 - d) A person whose appearance makes identification impossible
 - e) A person who does not have an identity document to confirm age of majority.
 - f) If the limit of available places is exhausted, the order of arrival determines entry to the event area.
3. The Event Participant and all persons present on the Event premises are obliged to behave in a way that does not threaten the safety of other event participants.
4. The event participant is obliged to follow the instructions given by the Organizer and the event security coordinator, aimed at ensuring safety and order at the event venue.
5. The Event Participant bears full financial responsibility for damage caused by him/her in the area where the Event takes place towards other participants as well as for damage caused to the Organizer's property.

6. The event participant is obliged to participate in the event in accordance with applicable law, and in particular to comply with fire safety regulations and the provisions of the regulations.
7. In the event of disturbing public order and peace, the Event Organizer may request the Event Participant to behave appropriately and, in the event of further violation of the rules of participation in the event, request that the Participant leave the Event premises.
8. In the event of noticing a fire or other event posing a threat to life, health or property, Participants and persons present at the Event premises should:
 - a) notify the Organizer immediately
 - b) avoid panic, follow the given instructions
 - c) leave the event venue calmly
9. In the event of health damage, participants are obliged to report this situation to the Event Organizer. During the event, there will be people trained in providing first aid on the premises. The medical kit is located at the reception desk of the Academic Sports Center.
10. Participation in the Event is tantamount to acceptance of these regulations by the Event Participant.
11. On the event premises it is prohibited:
 - a) terracing and blocking exits and evacuation routes, access roads for rescue services, as well as hydrants and other devices necessary in the event of a rescue operation.
 - b) entering areas that are not intended for Event participants
 - c) sales, advertising, acquisitions - without the prior consent of the organizer.
 - d) littering the event area and destroying its infrastructure.
 - e) lighting a fire
 - f) introducing animals
 - g) recording the event using a camera, telephone or other electronic devices and distributing such recorded materials using any techniques, regardless of the purposes of dissemination.
 - h) destroying or damaging elements of the facility's equipment, any devices located on the event premises and any property belonging to other event participants.

Final Provisions

1. The event regulations are available at the information point at the entrance to the event and on the organizer's website.
2. In matters not regulated by the provisions of the regulations, the provisions of generally applicable law and the regulations in force at the facility shall apply.
3. The Regulations enter into force on October 20, 2025, and are valid until the end and settlement of the Event, but no later than October 30, 2025.
