### Information on the processing of the image as personal data

1. 2. Pursuant to Art. 37 (1)(a) GDPR, the Administrator appointed the Data Protection Officer, with whom you can contact in matters related to the processing of personal data by e-mail at: [iod@pb.edu.pl](mailto:iod@pb.edu.pl).
3. Your image will be processed in order to document your participation in the project 'Together Towards Excellence – Białystok University of Technology in the Activities of the Across-BUT Across Alliance' on the basis of art. 6 1 item e GDPR and pursuant to art. 6 1 item a GDPR for information and promotional purposes in the field of publication of individual images of project participants.
4. For the purposes mentioned above, we may share your image with the following recipients: users of Administrator's website and users of social networking sites on which Administrator has accounts, Administrator's IT service providers, the Polish National Agency for Academic Exchange and other persons acting for the Agency.
5. The image will be stored for the period necessary to achieve the aforementioned purpose.
6. You have the right to access your data, and, within the regulations of the law, to:
  - 1) withdraw the consent granted, provided that the withdrawal of the consent will not affect the lawfulness of the processing carried out on the basis of the consent granted before its withdrawal,
  - 2) rectify your data,
  - 3) erase your data,
  - 4) restrict the data processing,
  - 5) object to the processing of your data.
7. The provision of data is voluntary and you are not obliged to provide it.
8. If you consider that processing of your image as a personal data violates the data protection legislation, you have the right to lodge a complaint with the President of the Office for Personal Data Protection,
9. your personal data will not be used for automated decision-making or profiling referred to in Art. 22 of the Regulation.
